Income Eligibility Limits

The Heart of Iowa School Tuition Organization (STO), Inc. has complete discretion regarding grants awarded. The Heart of Iowa STO will send grants directly to the school where the student is enrolled, and the grant will be applied to the student's tuition account. If the student does not complete a full year of school, the awarded grant will be prorated based on the number of days enrolled, and the unused portion will be returned to the Heart of Iowa STO.

To be eligible for a grant, your **Total Income (Line 6 on the 2018 Federal 1040)** cannot exceed the amount listed below for your household size. The Income Limits are based on 400% of the current Federal Poverty Guidelines.
